

# 2021 Spring *Virtual* Conference by Megann McGill

Join us on Saturday, March 6, 2021!

This half-day workshop will focus on serving clients who need augmentative and alternative communication (AAC) support delivered via telepractice. Speech-language pathologists (SLPs) often report limited training in augmentative and alternative communication (AAC) (ATIA, 2012; Johnson & Prebor, 2019). Since early 2020, an outbreak of COVID-19 required many clinicians to transfer their caseloads from in-person to telehealth services. Limited training in this service modality may result in additional barriers to high-quality AAC services. The purpose of this presentation is to prepare SLPs to deliver effective AAC assessments and evidence-based interventions via telehealth. Barriers and potential solutions for assessment and treatment will be discussed. Contemporary issues related to telepractice service delivery in AAC will be reviewed. This session will be led by Brandon Eddy, M.A., CCC-SLP, an Assistant Clinical Professor in the Department of Speech & Hearing Sciences at Portland State University. He is also an SLP at Shriners Hospitals for Children, and a Research Associate with the REKNEW Lab at OHSU.

## Open OSHA Board Positions

OSHA would like to announce two open board positions: the Clinic-Based SLP Professional Affiliate and the Ethical Practices Committee Chair. Please review the descriptions below and email <a href="mailto:oshaoregon@gmail.com">oshaoregon@gmail.com</a> by March 12, 2021, if interested.

#### **Clinic-Based SLP Professional**

The role of the Clinic-Based SLP Professional Affiliate is to provide guidance to the OSHA Board on matters relating to the clinical practice of speech-language pathology; to facilitate continuing education activities specific to the clinical practice of speech-language pathology; and to provide information regarding issues of clinical practice relating to quality assurance, standards of practice, clinical outcomes, and licensure.

#### 1.0 **PURPOSE**

The purpose of this Policy is to identify the responsibilities of the Clinic-Based SLP Professional Affiliate.

#### 2.0 **SCOPE**

This Policy applies to all persons directly [or indirectly] connected with the Oregon Speech-Language and Hearing Association.

#### 3.0 **QUALIFICATIONS**

The Clinic-Based SLP Professional Affiliate shall be an OSHA member in good standing.

#### 4.0 APPOINTMENT AND TERM

- The Clinic-Based SLP Professional Affiliate shall be elected the Executive Committee.
- The Clinic-Based SLP Professional Affiliate shall serve in accordance with the terms outlined in Article V of the Association's Bylaws.

#### 5.0 **RESPONSIBILITIES**

Responsibilities include:

- Serve as a voting member of the OSHA Board.
- Advise the Board on issues pertaining to the clinical practice of speech-language pathology.
- Assist the Conference Committee in developing the Fall Conference continuing education activities specific to the needs of the members practicing in clinical settings.
- Assist the OSHA lobbyist and Vice President of Governmental Affairs with preparation of testimony for governmental entities on issues affecting the clinical practice of speech-language pathology.
- Gather and report information pertinent to clinical practice to the OSHA Board and to the membership at the annual business meeting, newsletter, etc.
- Recruit committee members and chair meetings as needed to fulfill the duties of the position; maintain appropriate records of committee meetings.

#### **Ethical Practices Committee Chair**

The role of the Ethical Practices Committee, headed by the Ethical Practices Chair, is to provide education regarding ethical practices and respond to inquiries about ethical practices

#### 1.0 **PURPOSE**

The purpose of this Policy is to identify the responsibilities of the Ethical Practices Committee Chair.

#### 2.0 **SCOPE**

This Policy applies to all persons directly [or indirectly] connected with the Oregon Speech-Language and Hearing Association.

#### 3.0 **QUALIFICATIONS**

The Ethical Practices Committee Chair shall be an OSHA member in good standing.

#### 4.0 APPOINTMENT AND TERM

- The Ethical Practices Committee Chair shall be appointed by the OSHA President.
- The Ethical Practices Committee Chair's term shall be one year with the option to renew for additional one-year terms as approved by the OSHA President.

#### 5.0 **RESPONSIBILITIES**

Responsibilities include:

- Report to the OSHA Board on the activities of the Ethical Practices Committee and ethical issues brought to attention of the committee by practitioners and OSHA members.
- Work with Professional Affiliates and Regional Representatives to learn about ethical issues experiences in different areas of practice or regions of the state.
- Disseminate information regarding ethical practices, e.g., provide newsletter articles, articles and information for social media or website.
- Respond to inquiries regarding ethical questions.
- Recruit committee members and convene committee meetings as needed; document proceedings of any committee meetings.
- Refer complainants to the Board of Examiners for Speech-Language Pathology and Audiology and/or ASHA.

## ASHA-OSHA Email Regarding COVID-19 Vaccine

From: The Oregon Speech-Language and Hearing Association (OSHA) Board

RE: COVID Vaccine Distribution

OSHA supports priority access to COVID-19 vaccines approved by the Food and Drug Administration for audiologists and speech-language pathologists who provide in-person assessment and treatment services. The services that we provide are essential for individuals with communication, swallowing, and cognitive disorders. While some have provided services remotely, others, who work in settings such as hospitals, skilled nursing facilities, clinics, and schools, have not. Even with strict adherence to mask-wearing and social distancing, our members are at greater risk for acquiring the COVID-19 virus because of the need to interact closely with patients, clients, or students. In some cases, adequate personal protective equipment is not available, and yet our members, recognizing that human communication is essential, risk their lives to serve those with communication and related disorders.

As the COVID-19 vaccine distribution continues, we encourage you to review the distribution phases in Oregon to determine when you will be eligible for the vaccine. The Centers for Disease Control (CDC) has a link to each state vaccination distribution plan: <a href="https://www.cdc.gov/vaccines/covid-19/covid19-vaccination-quidance.html">https://www.cdc.gov/vaccines/covid-19/covid19-vaccination-quidance.html</a>.

OSHA will continue to advocate for priority vaccine access for our members recognizing that effective communication is essential and that our members will continue to provide needed services regardless of personal risk.

### **University of Oregon**

We are in the middle of Winter term at University of Oregon. Currently, classes and clinics are being done virtually. I am constantly impressed with the academic faculty's ability to keep the content rich and engaging in a virtual format yet maintaining the high level of quality they are known to deliver. We are continually impressed with our graduate clinicians' resiliency and optimism despite these unprecedented times as they shine in engaging clients across the lifespan in teletherapy. We have been fortunate in the continued approval for Telehealth to keep our on-campus HEDCO Speech-Language-Hearing Clinic robust. We even have seen some benefits in being able to serve more clients in their homes and being able to offer more services throughout the state. Last year we were able to graduate all students on time with their required clinical hours. We are planning now for Spring term clinic and are excited to announce the following opportunity.

The University of Oregon Speech-Language-Hearing Center is now recruiting families who speak Spanish to participate in a **FREE** 8-week intervention program for young children with communication disorders or delays. Language and Play Every Day en español is a culturally- and linguistically-responsive intervention focused on teaching Spanish-speaking caregivers to support the communication development of their child in home routines. To be eligible for the intervention, families must speak some amount of Spanish at home and have a child over the age of 2 who speaks fewer than 150 words. The intervention will be delivered *remotely* 1 time per week from **April 4th to May 31st** by master's students in speech-language pathology. The Medical Concentration will provide advanced specialty training for graduate students interested in a career as a medical Speech-Language Pathologist. It includes a variety of training opportunities such as clinical and instrumental assessment and treatment of dysphagia, motor speech, voice, craniofacial, language processing disorders, and cognitivecommunication with a variety of acquired, developmental and neurodegenerative adult and pediatric populations in the Portland metropolitan area.
