## **Continuing Education Information**

**ASHA CEU Processing Fee**: There is a \$5.00 processing fee for the Oregon Speech-Language & Hearing Association to report your CEUs to ASHA. This fee is charged by OSHA, not ASHA. To record your ASHA CEUs, you must include \$5.00 with your registration fee and complete a course evaluation form by end of day April 10, 2024. These forms will be shared in the chat at the end of the event and emailed out to all attendees.

**Program Completion Requirements**: Participants are expected to be present for the entire program. Individuals who are not present for the full program will not be recommended for ASHA CEUs. You must complete the online survey to earn CEUs. No partial credit will be provided.

**ASHA CE Registry Info:** An annual ASHA CE Registration fee is required for ASHA to automatically track your ASHA CEUs. # Narrative Mosaics: Assessment and Intervention of Narratives Across Cultures

#### **Course Description**

This workshop will explore the use of narratives as a context for language intervention. Using culturally responsive principles and practices, the presenters will describe structural and stylistic features of narratives across cultures, including the evaluation and selection of children's literature. Dynamic assessment of narrative comprehension and production will be discussed, followed by strategies and procedures for using storybooks as a context for language intervention at the word, sentence, and discourse levels.

## **Learning Objectives**

After completion of this conference session:

- 1. Participants will discuss stylistic and structural features of narratives across cultures.
- 2. Participants will plan a dynamic assessment around narrative comprehension and production.
- 3. Participants will assess and select storybooks based on culturally responsive principles.
- 4. Participants will use storybooks representing a variety of narrative structures to plan for word-level, sentence-level, and discourse-level language intervention.
